The following payment terms are acceptable: Net 30 with approved credit; COD; Pre-Paid (receive free freight in contiguous United States) with check, electronic check, money order, Visa, MasterCard, American Express, and Discover. International accounts require pre-paid wire transfer or credit card.
2. Minimum opening order is \$125.00 (Reorders are \$60.00)
3. All product orders must be by the half-dozens or dozens (except display programs).
4. This agreement includes all products of The Funny Guy Company.
5. Returned checks will be billed a \$20.00 handling fee.
6. All sales are final. Returns are only accepted on damaged goods only. No returns are accepted without issued Authorization number. If shipments arrive damaged or incomplete, contact Customer Service at The Funny Guy Company immediately or within 30 days from receipt of order. Claims may be deducted up to 90 days after notification.
7. Credit is established by completing our credit application.
8. All credits issued are applied towards future purchases. Sorry, no cash refunds.
9. Discounts, extended dating, free freight, and exchange privileges are contingent upon timely paying of The Funny Guy Company's invoices.
10. Back orders are shipped as soon as possible. Accounts that do not accept backorders should indicate that on their orders. Customers will be contacted per their wishes on how their backorder should be handled. Customers will not be charged for shipping costs on backorders, just on the product itself.
11. Orders must be submitted with complete information, including but not limited to, notation of shipping and billing addresses, correct wholesale pricing, terms, accurate quantities, promotional offers and multiple store distribution information, if applicable.
12. The Funny Guy Company provides wire racks at no cost with qualifying orders. Retailers provided the aforementioned agree that these will be used exclusively for the display of products from The Funny Guy Company.
13. The Funny Guy Company ships UPS Ground unless other arrangements have been made in advance with the retailer.
14. The Funny Guy Company reserves the right to adjust product prices, require COD shipment terms (if considered necessary), cancel this agreement by written notice to the retailer and charge back all freight charges, discounts, and rebates from the date of this agreement.
